At 13-years-old Jayson and his two siblings were removed from their father's care as a result of severe physical abuse. Their mother died several years prior, so they entered foster care. When their father's parental rights were terminated two years later, Jayson's siblings were adopted together, but he was not adopted with them.



Over the next couple years, the teen bounced between temporary

placements. He disengaged from school, therapy, and from speaking with the very people in his life trying to help him.

When Jayson was nearly 17 years old, the family of a good friend reached out to the State of New Hampshire to see if they could provide a home for the teen. He had spent a lot of time with this family and they "just clicked."

His CASA volunteer advocate could see how the teen's demeanor changed when he was with this family. Although the family wasn't licensed as a foster home, Jayson's advocate knew they could provide stability for the teen.

As he approached his 18th birthday in a home where he felt cared for, he began to re-engage with his caseworker and CASA volunteer. He decided to continue counseling, finish high school and take advantage of the extended services offered to him through DCYF.

Finally, Jayson found a home where he belonged, thanks to his new loving family and the support of his dedicated CASA volunteer advocate.

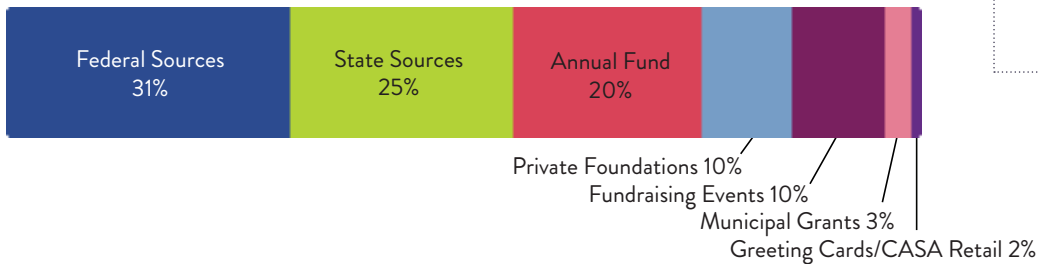

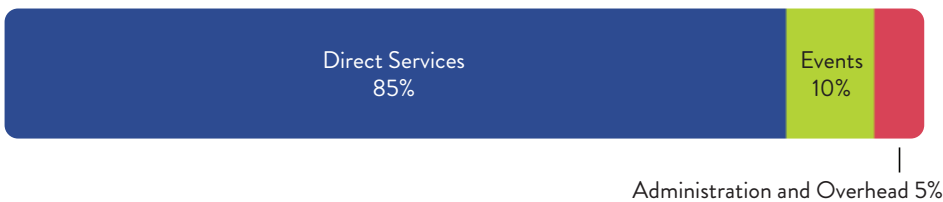
FUNDING SOURCES

CASA of NH strives to maintain frugal financial practices, a balanced budget and funding diversity.

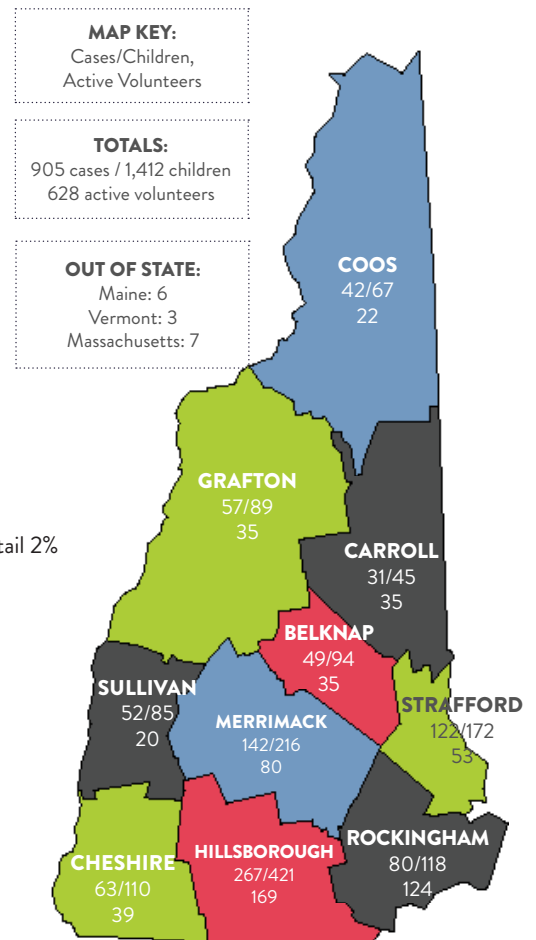


FUNDING USES
